For the subject job, we request you to tender your quotation in **Two bid system**, namely Techno-commercial Bid and Price Bid.

6. The techno-commercial bid shall contain:

a) Earnest money deposit and Tender paper Cost.

b) Work Order Copies of similar works carried out by the contractor in Fertilizers/Refineries/ Petrochemicals/ continuous process / power (plant/constuction /project etc.) along with Job Completion Certificate issued by the customer showing experience of having successfully completed similar works during last 5 years ending last day of month previous to one in which applications are invited either of the following:

i) Three similar completed works costing not less than the amount equal to Rs. 95,390.00.

Or

ii) Two similar completed works costing not less than the amount equal to Rs. 1,19,237.00.

Or

iii) One similar completed works costing not less than the amount equal to Rs.1,90,780.00.

c) Work Order copy must reflect experience of performing such similar jobs as mention above in name of work.

d) Party/ Contractors having up to date renewed Electrical License, Electrical supervisors certificate of Competency, in Form – B, issued by Electrical Licensing Board, Government of Assam, holding supervisors under their employment. The Electrical supervisor's certificate of Competency holder should be associated with the Contractor / firm and should be duly endorsed by the Electrical Licensing Board.

e) Party having registration fulfilling the conditions of statutory levies like GST etc. as admissible.

f) Party/ Contractor will have to furnish self certified photocopies of the following documents:

i) Copy of PAN /TAN Certificate issued by the concerned IT authority.

ii) Copy of GST Registration certificate.

iii) A declaration in the form of affidavit / declaration that he / she is not a partner / proprietor of any other firm /company participating in this tender of BVFCL.

8. After successful completion of the job, may be extended for one more year at the same rate, terms and condition

9. The Contractor shall ensure timely deployment of the required skilled and unskilled manpower against the requisition of the Engineer-In-Charge. The Contractor shall mobilize the manpower within 12 hours of receipt of notice through written communication, telephone/telecommunication, or email and shall maintain the required manpower availability for carrying out the assigned maintenance activities as directed by the Engineer-In-Charge.

10. The tenderer shall abide by all the statutory obligations under various statutory acts and rules made there. SCOPE OF WORK

1.01 CONTRACTOR'S SCOPE: Scope of work shall include but shall not be limited to the following for execution/ completion of work:-

- a) The Contractor shall ensure timely deployment and mobilization of the required skilled and unskilled manpower **within 12 hours of requisition** by the Engineer-In-Charge, as and when required.
- b) Execution of job as directed by Engineer-in-charge as per standards and laid down procedure.
- c) The Contractor shall arrange all necessary tools and tackles such as line tester, wire stripper, pliers and other hand tools required for execution of the assigned work.
- d) Contractor shall strictly follow and abide by all the Fire and Safety Regulations of BVFCL.
- e) Maintaining register for attendance of the personnel engaged/measurement of job executed duly countersigned by the engineer in charge.
- f) The Contractor shall provide necessary PPE such as safety helmet, safety shoes, hand gloves, safety goggles and other required safety equipment to the deployed manpower and ensure their proper usage during execution of work.
- g) The Contractor shall strictly follow all safety rules, procedures, work permit requirements and instructions of BVFCL. The deployed manpower shall be adequately trained and aware of the safety hazards associated with the assigned work.
- h) The Contractor shall be responsible for the safety of their personnel, tools and equipment during execution of work. Any accident or damage due to negligence or non-compliance with safety requirements shall be the responsibility of the Contractor.

1.02 BVFCL's SCOPE:

- a) Entry pass to enter inside the BVFCL premises shall be arranged.
- b) Required Safety Hand Lamps, Extension Boards and other specific equipment, wherever required, shall be provided by BVFCL.

1.00 INSTRUCTION FOR TENDERERS

- 1.01 The tenderer (s) should carefully read and understand all the tender documents before completing the required formalities and quoting the rates etc.
- 1.02 The tender documents completed in all respects and duly signed by the contractor should be sealed in a cover super scribing the tender No. name of the work and date of opening and address to the concerned officer along with the name and address of contractor.
- 1.03 The above cover containing all tender documents should be submitted in the respective office to reach the concerned office well in specific time.
- 1.04 The rates of items should be indicated in words as in figures and any cutting should be duly signed otherwise tender will be rejected. Overwriting in tender form will lead to its rejection.

2.00 TERMS & CONDITIONS

- 2.01 The contractors have to abide by all the terms and conditions mentioned here in respect of carrying out the job, payments, settlement of disputes etc. The tender should be carefully read and the clauses to be understood before filing up the tender documents.
- 2.02 The contractor should visit the site and acquaint himself with the site conditions etc. before submitting the tender.
- 2.03 All works are to be done under the strict supervision of the contractor to the entire satisfaction of the Engineer – in – charge / site in charge.

3.00 EARNEST MONEY

- 3.1 The tenderer shall deposit the Earnest money in mode of Challan receipt, in favour of BVFC LTD., Namrup , and attach receipt thereof with the tender. Earnest money shall not be accepted in any form other than these specified above and the tender not accompanied by Earnest money in the proper form may not be considered. No interest will be payable on the Earnest Money deposit under the contract.

4.00 CONTRACT LABOUR ACTS ETC.

- 4.1 The tenderer shall abide by all the provisions of Contract Labour Acts. and Rules issued by the Government and applicable to them. In case the tenderer fail to do so, this Corporation shall have the right to deduct from tenderer's bill, the expenses which are to be incurred in connection with any claim from any party including the labour engaged by the tenderer.
- 4.2 The contractor has to maintain a Register of his labourers with the particulars shown in the proforma to be supplied for implementation of the provisions of contract labour (Regulation and Abolition) act.1970.
- 4.3 The contractor shall make the payments of wages regularly to the labourers engaged by him in presence of a authorized representative appointed by BVFC Ltd. as per contract Labour Act.1970 and the minimum wages should be paid according to the circulars / directives issued by Central / State Govt. from time to time.

5.00 COMPENSATION

- 5.01 The contractor shall have to make an ex-gratia payment of Rs. 1000/- (Rupees one thousand) only to the dependants of labourer in the event of the labour's death occurring while on duty. This payment will be made by the BVFC Ltd. Immediately and will be recovered from the bills of contractor.

6.00 TOOLS & ACCOMODATION

- 6.1 The contractor shall make his own arrangements for providing accommodation, tools tackles etc. for his staff. Such facilities will not be provided by BVFCL.

7.00 SAFETY MEASURES

- 7.1 The contractor have to provide all necessary safety tools / equipments / accessories to his staff working at site as required under safety regulation of the factory.
- 7.2 Injuries or accidents to the contractor labour shall be taken care by contractor at his own cost and risk and shall comply with all Safety Rules and health regulations.
- 7.3 The contractor has to obtain safety permit from competent authority fro working in hazardous conditions and all safety rules should be followed strictly.

8.00 MEDICAL FACILITIES

- 8.1 No medical facilities will be provided free of cost except First Aid to the contractor's labourers.

9.00 PAYMENT TERMS

- 9.1 Payment shall be released on 100% basis against the work executed and satisfactorily completed by the Contractor, subject to certification by the Site Engineer.
